## Transaction Summary

The transaction closed on May 17 2018 and matures in May 2033. The pool's current aggregate principal balance is \$751.4 million compared to \$767.3 million at close.

The largest loan of the pool (8.8%) is secured by Village at Leesburg located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 91%. The major tenants included Wegman's (26.13%) and Cobb Theaters (11.66%). The second largest loan of the pool (6.7%) is secured by 3495 Deer Creek Road located in metropolitan area. Occupancy at the subject was 100%. The major tenants included VMware INC. (100.00%) and Sprint (0.33%). The third largest loan of the pool (6.3%) is secured by Airport Business Center located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 94%. The major tenants included JustFoodForDogs LLC (1.55%) and Aids Services Foundation Inc. (1.01%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.85% and 47 months as of 03/15/2022, respectively. There are a total of 44 loans and 55 properties in the portfolio. The appraisal LTV was approximately 64.4% compared to the Original loan to value (LTV), which was approximately 62.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.64x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

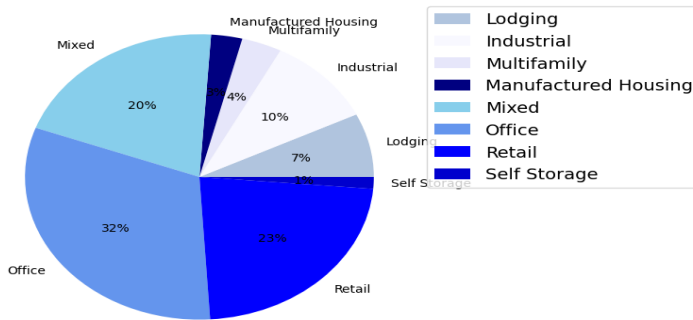

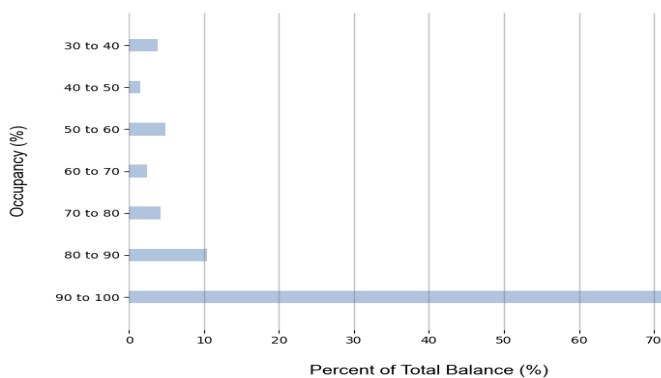

### Occupancy Distribution (%)

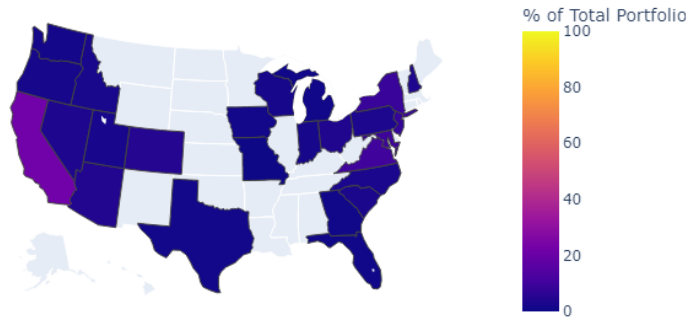

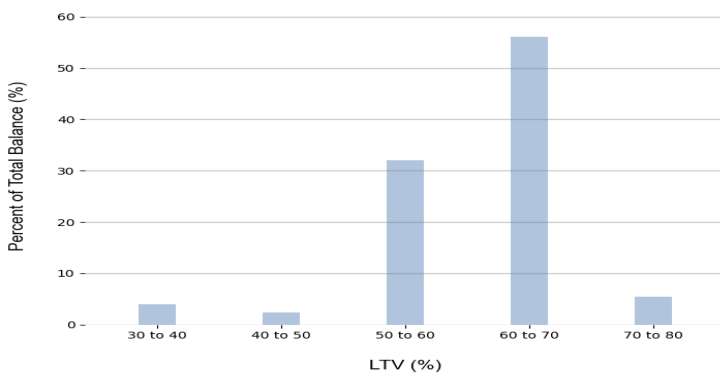
Local Distribution

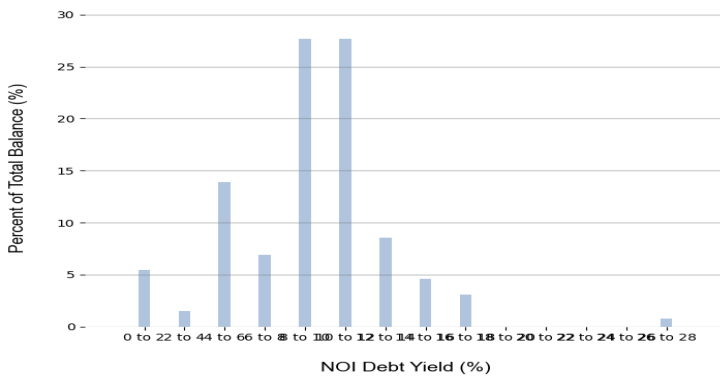

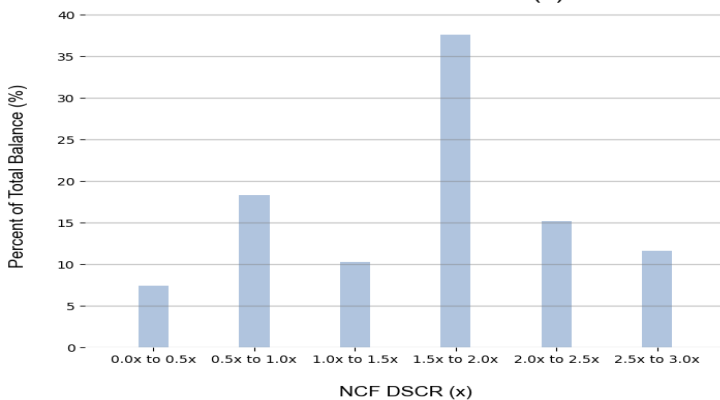
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

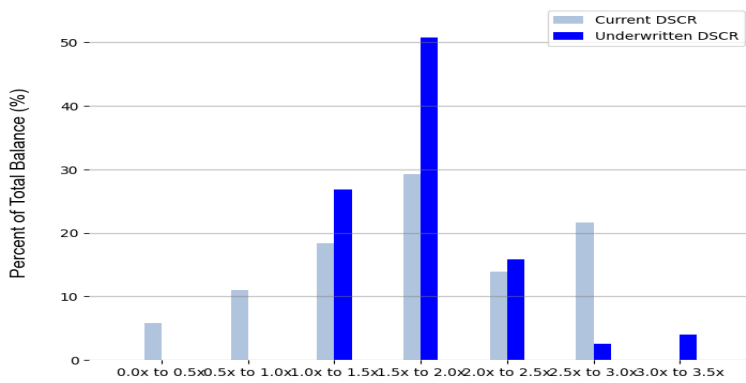

There were 5 assets (7.4% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (18.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 8 assets (10.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (37.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (15.1% of total balance) with NCF DSCR between 2.0x and 2.5x and 3 assets (11.5% of total balance) with NCF DSCR between 2.5x and 3.0x. 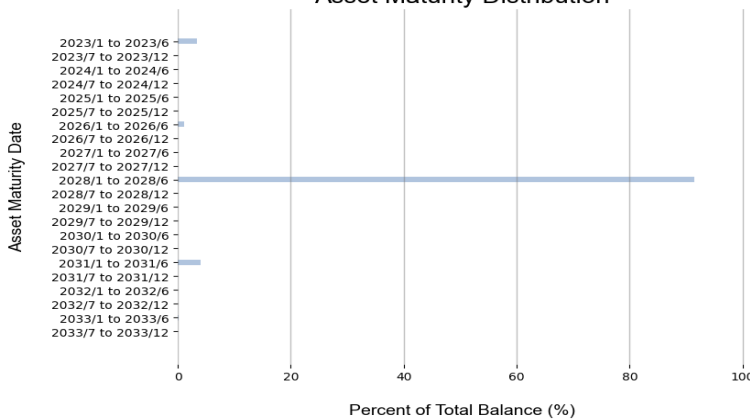
**DSCR Distribution (x)**

There are 4 assets (5.9% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (11.0% of total balance) with DSCR between 0.5x and 1.0x, 8 assets (18.3% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (29.3% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (13.9% of total balance) with DSCR between 2.0x and 2.5x and 6 assets (21.6% of total balance) with DSCR between 2.5x and 3.0x. The most recent weighted average DSCR is 1.8x.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
