Transaction Summary

The transaction closed on Jul 17 2018 and matures in Apr 2031. The pool's current aggregate principal balance is \$653.9 million compared to \$659.0 million at close.

The largest loan of the pool (10.0%) is secured by Village at Leesburg located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 93%. The major tenants included Wegman's (26.13%) and Cobb Theaters (11.66%). The second largest loan of the pool (7.4%) is secured by Westport Self Storage Portfolio located in Fort Worth-Arlington, TX-11.20% Dallas-Plano-Irving, TX-6.95% metropolitan area. Occupancy at the subject was 84%. The third largest loan of the pool (6.5%) is secured by Parkway Center located in metropolitan area. Occupancy at the subject was 82%. The major tenants included Quest Diagnostics (23.13%) and McKesson Corporation (8.39%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.90% and 31 months as of 12/15/2020, respectively. There are a total of 49 loans and 89 properties in the portfolio. The appraisal LTV was approximately 61.3% compared to the Original loan to value (LTV), which was approximately 61.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.79x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





Occupancy Distribution (%)




Local Distribution



Among assets in the portfolio, there are 11 properties (27% of total balance) located in California, 14 properties (11% of total balance) in Texas, 3 properties (11% of total balance) in Virginia, 9 properties (7% of total balance) in Ohio, 1 property (7% of total balance) in Pennsylvania, 8 properties (6% of total balance) in North Carolina, 1 property (4% of total balance) in Delaware and 4 properties (4% of total balance) in Tennessee. 



Most recent net operating income debt yield ranged from 0% to 19% with a weighted average NOI debt yield of 10.0%. NOI debt yield ranged from 0% to 19%. There were 1 assets (3% of total balance) with NOI debt yield between 0% and 2%, 3 assets (18% of total balance) with NOI debt yield between 6% and 8%, 13 assets (38% of total balance) with NOI debt yield between 8% and 10%, 17 assets (27% of total balance) with NOI debt yield between 10% and 12%, 6 assets (6% of total balance) with NOI debt yield between 12% and 14%, 5 assets (5% of total balance) with NOI debt yield between 14% and 16%, 3 assets (3% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%

NCF DSCR ranged from 0.0x to 3.0x. There were 3 assets (4.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (16.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 26 assets (45.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (31.9% of total balance) with NCF DSCR between 2.0x and 2.5x and 2 assets (1.7% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.8x.







DSCRs ranged from 0.0x to 3.5x.There are 3 assets (4.9% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (10.3% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (40.8% of total balance) with DSCR between 1.5x and 2.0x, 21 assets (42.3% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (1.4% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (0.4% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 1.9x

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
