Transaction Summary

The transaction closed on Oct 25 2018 and matures in Oct 2028. The pool's current aggregate principal balance is \$932.6 million compared to \$946.6 million at close.

The largest loan of the pool (7.5%) is secured by Starwood Hotel Portfolio located in West Palm Beach-Boca Raton-Delray Beach, FL-8.27% Lake County-Kenosha County, IL-WI-5.08% metropolitan area. Occupancy at the subject was 44%. The second largest loan of the pool (5.4%) is secured by Aventura Mall - Trust located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 89%. The major tenants included JCPenney (15.91%) and AMC Theatres (6.47%). The third largest loan of the pool (5.4%) is secured by Christiana Mall - Trust located in Wilmington, DE-MD-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Target (Ground Lease) (18.65%) and Cabela's (Ground Lease) (12.84%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.95% and 42 months as of 03/15/2022, respectively. There are a total of 73 loans and 105 properties in the portfolio. The appraisal LTV was approximately 59.1% compared to the Original loan to value (LTV), which was approximately 58.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.53x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.





Occupancy Distribution (%)




Local Distribution









EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
