## Transaction Summary

The transaction closed on May 14 2019 and matures in May 2029. The pool's current aggregate principal balance is \$910.8 million compared to \$917.6 million at close.

The largest loan of the pool (4.8%) is secured by Crown Center Office Park located in Fort Lauderdale-Pompano Beach-Deerfield Beach, FL metropolitan area. Occupancy at the subject was 82%. The major tenants included Bayview Loan Servicing LLC (13.23%) and CBS Broadcasting (10.12%). The second largest loan of the pool (3.8%) is secured by Ohio Hotel Portfolio located in metropolitan area. Occupancy at the subject was 75%. The third largest loan of the pool (3.8%) is secured by Great Wolf Lodge Southern California - Trust located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 87%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.03% and 19 months as of 10/15/2020, respectively. There are a total of 63 loans and 345 properties in the portfolio. The appraisal LTV was approximately 64.3% compared to the Original loan to value (LTV), which was approximately 62.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.93x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

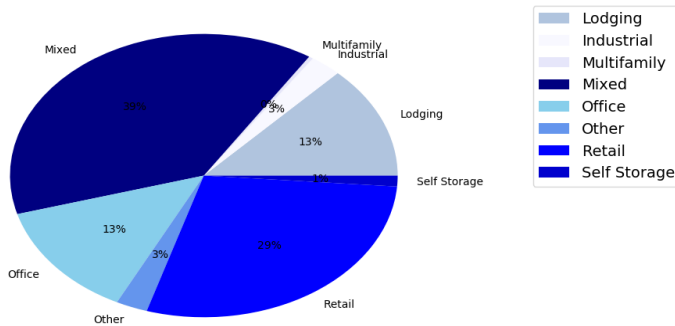

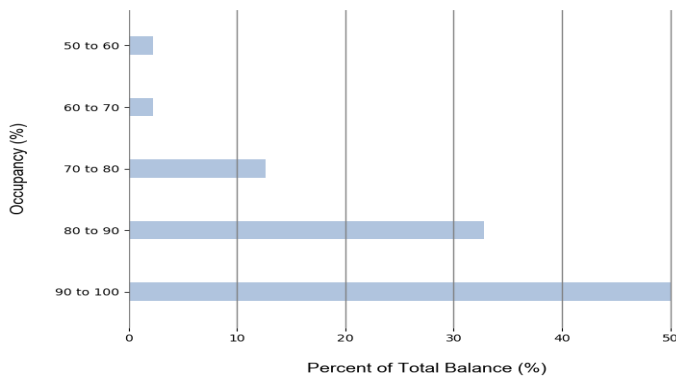

Occupancy Distribution (%)

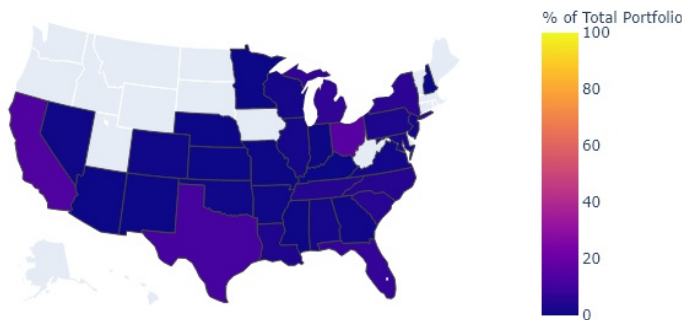

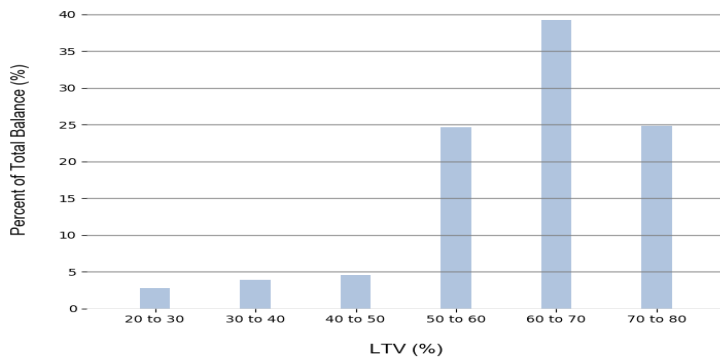
Local Distribution

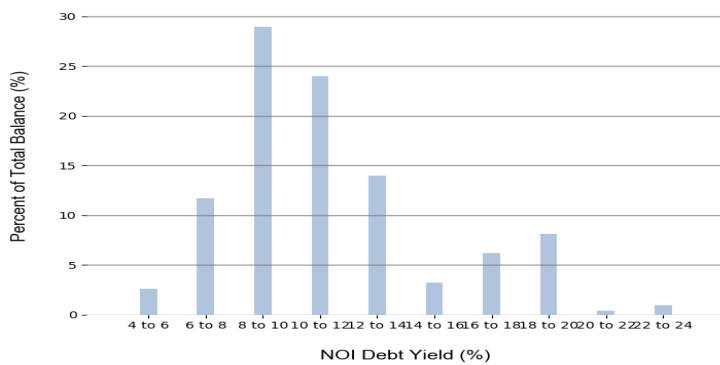

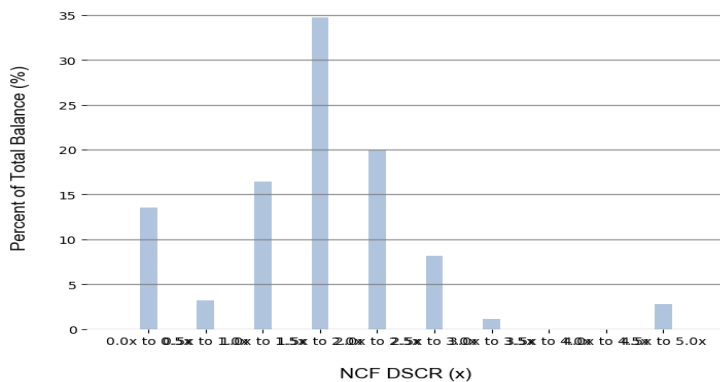
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 23% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 4% to 23%. There were 1 assets (3% of total balance) with NOI debt yield between 4% and 6%, 6 assets (12% of total balance) with NOI debt yield between 6% and 8%, 19 assets (29% of total balance) with NOI debt yield between 8% and 10%, 16 assets (24% of total balance) with NOI debt yield between 10% and 12%, 9 assets (14% of total balance) with NOI debt yield between 12% and 14%, 3 assets (3% of total balance) with NOI debt yield between 14% and 16%, 4 assets (6% of total balance) with NOI debt yield between 16% and 18%, 3 assets (8% of total balance) with NOI debt yield between 18% and 20%, 1 assets (0% of total balance) with NOI debt yield between 20% and 22% and 1 assets (1% of total balance) with NOI debt yield between 22% and 24%.

Net Cash Flow DSCR (x)

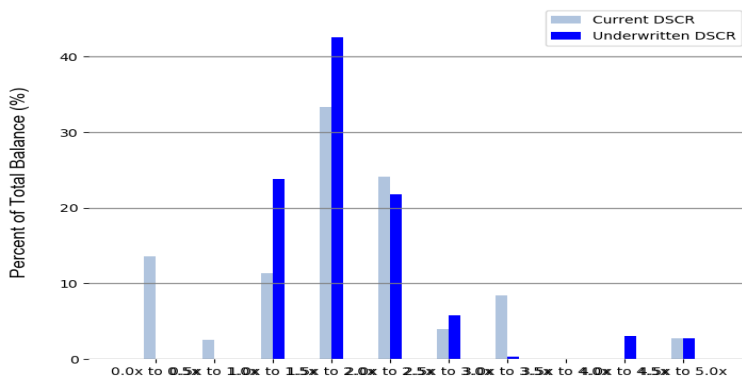


NCF DSCR ranged from 0.0x to 5.0x. There were 7 assets (13.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (3.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (16.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 19 assets (34.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (20.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (8.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.1% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (2.7% of total balance) with NCF DSCR between 4.5x and 5.0x. 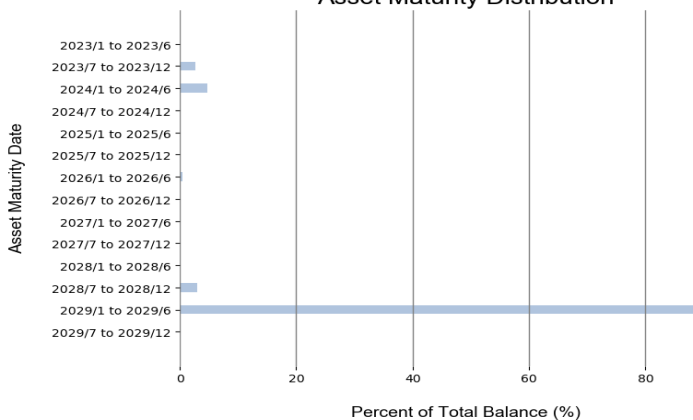
**DSCR Distribution (x)**



DSCRs ranged from 0.0x to 5.0x. There are 7 assets (13.5% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (2.6% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (11.3% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (33.4% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (24.1% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (3.9% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (8.4% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (2.7% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.1x.

There are 1 assets (2.7% of total balance) that have maturity dates between 2023/7 and 2023/12, 2 assets (4.7% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (0.4% of total balance) that have maturity dates between 2026/1 and 2026/6, 2 assets (3.0% of total balance) that have maturity dates between 2028/7 and 2028/12 and 57 assets (89.2% of total balance) that have maturity dates between 2029/1 and 2029/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
