## **Transaction Summary**

The transaction closed on Jul 11 2019 and matures in Jun 2029. The pool's current aggregate principal balance is \$724.6 million compared to \$729.9 million at close.

The largest loan of the pool (9.8%) is secured by Nova Place located in metropolitan area. Occupancy at the subject was 84%. The major tenants included PNC Bank (34.62%) and United HealthCare (6.26%). The second largest loan of the pool (6.5%) is secured by 188 Spear Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 100%. The major tenants included Amazon.com (59.08%) and New Relic Inc (33.56%). The third largest loan of the pool (6.2%) is secured by 450-460 Park Avenue South located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 95%. The major tenants included 460 Park Aven South Tenant LLC (41.77%) and ShopKeep Inc. (12.85%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.53% and 19 months as of 12/15/2020, respectively. There are a total of 54 loans and 105 properties in the portfolio. The appraisal LTV was approximately 62.9% compared to the Original loan to value (LTV), which was approximately 63.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.08x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.





## Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 4% to 17% with a weighted average NOI debt yield of 9.1%. NOI debt yield ranged from 4% to 17%. There were 3 assets (11% of total balance) with NOI debt yield between 4% and 6%, 7 assets (24% of total balance) with NOI debt yield between 6% and 8%, 21 assets (34% of total balance) with NOI debt yield between 8% and 10%, 12 assets (16% of total balance) with NOI debt yield between 10% and 12%, 8 assets (12% of total balance) with NOI debt yield between 12% and 14%, 2 assets (2% of total balance) with NOI debt yield between 14% and 16% and 1 assets (1% of total balance) with NOI debt yield between 16% and 18%.





# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
