Transaction Summary

The transaction closed on Aug 20 2019 and matures in Jun 2039. The pool's current aggregate principal balance is \$894.8 million compared to \$900.6 million at close.

The largest loan of the pool (5.6%) is secured by Moffett Towers II - Buildings 3 & 4 - Trust located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Facebook (100.00%). The second largest loan of the pool (4.6%) is secured by University Town Center located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Academy Sports + Outdoors (19.87%) and TJ Maxx (7.45%). The third largest loan of the pool (4.5%) is secured by SoCal Retail Portfolio located in Los Angeles-Long Beach-Glendale, CA-60.66% metropolitan area. Occupancy at the subject was 99%. The major tenants included The Home Depot GROUND LEASE (10.10%) and Target (9.05%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 17 months as of 12/15/2020, respectively. There are a total of 67 loans and 126 properties in the portfolio. The appraisal LTV was approximately 61.3% compared to the Original loan to value (LTV), which was approximately 61.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.11x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.





Occupancy Distribution (%)






Local Distribution





There were 41 assets (55.7% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (4.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 9 assets (7.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 6 assets (15.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (12.6% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (0.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (2.0% of total balance) with NCF DSCR between 5.5x and 6.0x and 1 assets (1.1% of total balance) with NCF DSCR between 10.5x and 11.0x. The most recent weighted average NCF DSCR was 2.1x.







There are 41 assets (55.7% of total balance) with DSCR between 0.0x and 0.5x, 9 assets (10.8% of total balance) with DSCR between 1.0x and 1.5x, 7 assets (12.9% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (13.1% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (4.4% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (2.0% of total balance) with DSCR between 5.5x and 6.0x and 1 assets (1.1% of total balance) with DSCR between 11.0x and 11.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
