Transaction Summary

The transaction closed on Dec 03 2019 and matures in Nov 2034. The pool's current aggregate principal balance is \$665.6 million compared to \$670.0 million at close.

The largest loan of the pool (8.3%) is secured by Continental Park - Rosecrans Douglas located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 61%. The major tenants included MOTOR TREND GROUP LLC (29.08%) and CBRE (14.95%). The second largest loan of the pool (5.2%) is secured by West Bountiful Commons located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Costco (41.62%) and At Home (31.32%). The third largest loan of the pool (4.8%) is secured by Torrey Ridge Apartments located in metropolitan area. Occupancy at the subject was 96%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.89% and 30 months as of 04/15/2022, respectively. There are a total of 44 loans and 88 properties in the portfolio. The appraisal LTV was approximately 64.4% compared to the Original loan to value (LTV), which was approximately 63.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.13x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.



Type Concentration











Most recent net operating income debt yield ranged from 2% to 25% with a weighted average NOI debt yield of 9.1%. NOI debt yield ranged from 2% to 25%. There were 1 assets (2% of total balance) with NOI debt yield between 2% and 4%, 2 assets (2% of total balance) with NOI debt yield between 4% and 6%, 9 assets (27% of total balance) with NOI debt yield between 6% and 8%, 22 assets (48% of total balance) with NOI debt yield between 8% and 10%, 6 assets (15% of total balance) with NOI debt yield between 10% and 12%, 1 assets (2% of total balance) with NOI debt yield between 12% and 14%, 1 assets (1% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 24% and 26%





DSCRs ranged from 0.0x to 4.5x.There are 4 assets (10.4% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (4.8% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (4.8% of total balance) with DSCR between 1.0x and 1.5x, 7 assets (17.1% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (34.6% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (18.2% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (7.5% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.2% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.4% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.2x.

There are 1 assets (25.0% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (5.0% of total balance) that have maturity dates between 2029/1 and 2029/6, 41 assets (616.4% of total balance) that have maturity dates between 2029/7 and 2029/12 and 1 assets (19.2% of total balance) that have maturity dates between 2034/7 and 2034/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3). The economy and regulation policies will remain stable in the foreseeable future.
