# **Transaction Summary**

The transaction closed on Aug 26 2020 and matures in Jan 2035. The pool's current aggregate principal balance is \$555.2 million compared to \$561.0 million at close.

The largest loan of the pool (10.1%) is secured by PGH17 Self Storage Portfolio located in Nassau County-Suffolk County, NY-5.61% metropolitan area. Occupancy at the subject was 91%. The second largest loan of the pool (8.3%) is secured by Phoenix Industrial Portfolio IV located in metropolitan area. Occupancy at the subject was 90%. The major tenants included Cupertino Electric Inc. (35.82%) and MWD logistics (21.20%). The third largest loan of the pool (6.3%) is secured by Hilton Garden Inn - Goleta located in metropolitan area. Occupancy at the subject was 69%.


The weighted average coupon (WAC) and the weighted average age (WALA) were 4.05% and 23 months as of 04/15/2022, respectively. There are a total of 40 loans and 71 properties in the portfolio. The appraisal LTV was approximately 65.4% compared to the Original loan to value (LTV), which was approximately 65.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.17x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.















# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
