# **Transaction Summary**

The transaction closed on Nov 20 2013 and matures in Nov 2043. The pool's current aggregate principal balance is \$636.3 million compared to \$698.1 million at close.

The largest loan of the pool (11.8%) is secured by Hilton Sandestin Beach Resort & Spa located in metropolitan area. Occupancy at the subject was 67%. The second largest loan of the pool (8.6%) is secured by Westfield Mission Valley located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Target (20.54%) and Bed Bath & Beyond (7.94%). The third largest loan of the pool (7.3%) is secured by One Bridge Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 97%. The major tenants included EILEEN FISCHER INC. (19.06%) and Lockard & Wechsler LLC (12.25%).

age (WALA) were 5.11% and 86 months as of 12/15/2020, respectively. There are a total of 75 loans and 97 properties in the portfolio. The appraisal LTV was approximately 55.5% compared to the Original loan to value (LTV), which was approximately 60.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.28x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.





#### Occupancy Distribution (%)




#### Local Distribution







DSCRs ranged from -0.5x to 5.5x. There are 1 assets (1.4% of total balance) with DSCR between -0.5x and 0.0x, 1 assets (0.2% of total balance) with DSCR between 0.5x and 1.0x, 16 assets (15.8% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (31.1% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (15.6% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (6.8% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (11.8% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (2.3% of total balance) with DSCR between 3.5x and 4.0x, 2 assets (3.2% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (11.8% of total balance) with DSCR between 5.0x and 5.5x. The most recent weighted average DSCR is 2.5x.

There are 73 assets (96.7% of total balance) that have maturity dates between 2023/7 and 2023/12, 1 assets (2.1% of total balance) that have maturity dates between 2025/7 and 2025/12 and 1 assets (1.2% of total balance) that have maturity dates between 2043/7 and 2043/12.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:
