Transaction Summary

The transaction closed on Dec 23 2013 and matures in Jan 2024. The pool's current aggregate principal balance is \$854.1 million compared to \$919.7 million at close.

The largest loan of the pool (17.6%) is secured by Garden State Plaza located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 85%. The major tenants included Macy's (20.02%) and Nordstrom (11.17%). The second largest loan of the pool (13.9%) is secured by AmericasMart located in metropolitan area. Occupancy at the subject was 82%. The major tenants included Exhibition Space (23.14%) and LINK 2 SALES LLC (0.83%). The third largest loan of the pool (16.4%) is secured by The Outlet Collection - Jersey Gardens located in Newark, NJ-PA metropolitan area. Occupancy at the subject was 95%. The major tenants included AMC Cinema (8.47%) and Burlington Coat Factory (6.18%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.73% and 82 months as of 10/15/2020, respectively. There are a total of 60 loans and 63 properties in the portfolio. The appraisal LTV was approximately 52.7% compared to the Original loan to value (LTV), which was approximately 53.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.78x. As of 10/15/2020, 16.39% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.



Type Concentration











There were 9 assets (20.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 11 assets (6.6% of total balance) with NCF DSCR between 1.0x and 1.5x, 20 assets (13.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 14 assets (10.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (15.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (15.2% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.8% of total balance) with NCF DSCR between 3.5x and 4.0x and 2 assets (34.0% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from 0.5x to 5.0x. There are 6 assets (6.3% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (18.8% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (10.9% of total balance) with DSCR between 1.5x and 2.0x, 15 assets (12.3% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (17.0% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.8% of total balance) with DSCR between 3.5x and 4.0x and 2 assets (34.0% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.9x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
