Transaction Summary

The transaction closed on Dec 11 2013 and matures in Mar 2024. The pool's current aggregate principal balance is \$393.5 million compared to \$432.3 million at close.

The largest loan of the pool (8.2%) is secured by Ocean Breeze Apartments located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 94%. The second largest loan of the pool (7.1%) is secured by Dollar General Portfolio located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Dollar General (99.26%). The third largest loan of the pool (5.5%) is secured by North County Village located in metropolitan area. Occupancy at the subject was 100%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.07% and 85 months as of 12/15/2020, respectively. There are a total of 47 loans and 85 properties in the portfolio. The appraisal LTV was approximately 60.0% compared to the Original loan to value (LTV), which was approximately 66.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.87x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.





Occupancy Distribution (%)




Local Distribution



Among assets in the portfolio, there are 14 properties (18% of total balance) located in Texas, 7 properties (12% of total balance) in Colorado, 4 properties (11% of total balance) in California, 4 properties (7% of total balance) in Georgia, 14 properties (7% of total balance) in Oklahoma, 7 properties (6% of total balance) in New Mexico, 2 properties (5% of total balance) in Nevada and 3 properties (4% of total balance) in Florida. 



Most recent net operating income debt yield ranged from 8% to 29% with a weighted average NOI debt yield of 14.8%. NOI debt yield ranged from 8% to 29%. There were 4 assets (9% of total balance) with NOI debt yield between 8% and 10%, 8 assets (25% of total balance) with NOI debt yield between 10% and 12%, 9 assets (28% of total balance) with NOI debt yield between 12% and 14%, 8 assets (15% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 6 assets (7% of total balance) with NOI debt yield between 18% and 20%, 2 assets (2% of total balance) with NOI debt yield between 20% and 22%, 4 assets (4% of total balance) with NOI debt yield between 22% and 24%, 3 assets (4% of total balance) with NOI debt yield between 24% and 26%, 1 assets (3% of total balance) with NOI debt yield between 26% and 28% and 1 assets (2% of total balance) with NOI debt yield between 28% and 30%.

NCF DSCR ranged from 0.0x to 5.0x. There were 1 assets (1.8% of total balance) with NCF DSCR between 0.0x and 0.5x, 10 assets (19.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (42.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 10 assets (20.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 5 assets (7.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 3 assets (3.3% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (0.6% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (0.6% of total balance) with NCF DSCR between 4.5x and 5.0x. 



There are 1 assets (1.8% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (6.4% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (43.0% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (30.2% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (6.9% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (6.4% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (2.7% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (1.9% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.6% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
