Transaction Summary

The transaction closed on Mar 28 2014 and matures in Mar 2044. The pool's current aggregate principal balance is \$909.2 million compared to \$1019.2 million at close.

The largest loan of the pool (9.3%) is secured by Renaissance Chicago Downtown located in metropolitan area. Occupancy at the subject was 80%. The second largest loan of the pool (6.8%) is secured by Life Time Fitness Portfolio located in Washington-Arlington-Alexandria, DC-VA-MD-WV-20.07% metropolitan area. Occupancy at the subject was 100%. The largest tenant was LTF Club Operations Company Inc. (100.00%). The third largest loan of the pool (5.8%) is secured by Nordic Cold Storage Portfolio located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Nordic Cold Storage LLC (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.99% and 82 months as of 12/15/2020, respectively. There are a total of 89 loans and 110 properties in the portfolio. The appraisal LTV was approximately 59.5% compared to the Original loan to value (LTV), which was approximately 63.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.74x. As of 12/15/2020, 9.28% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

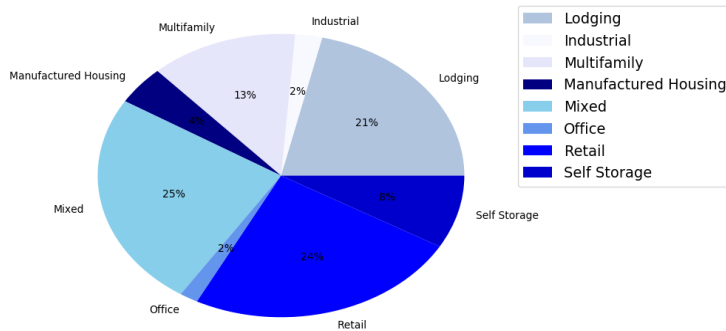

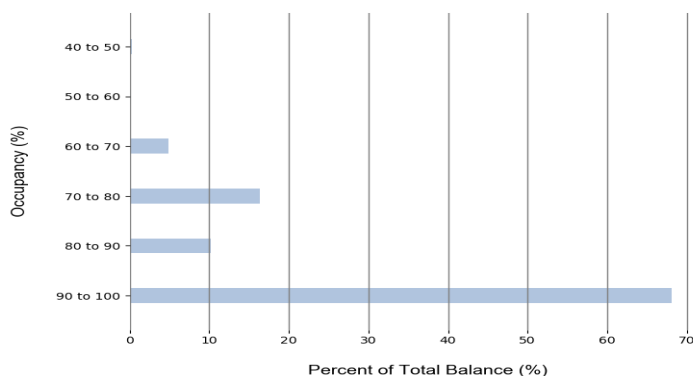

Occupancy Distribution (%)

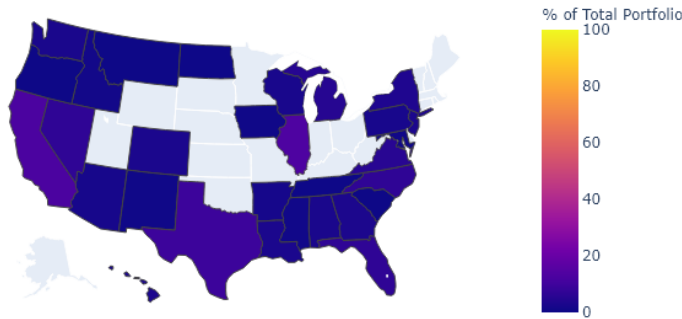

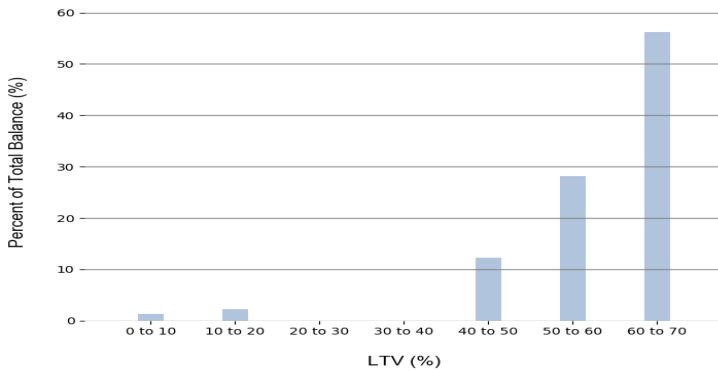
Local Distribution

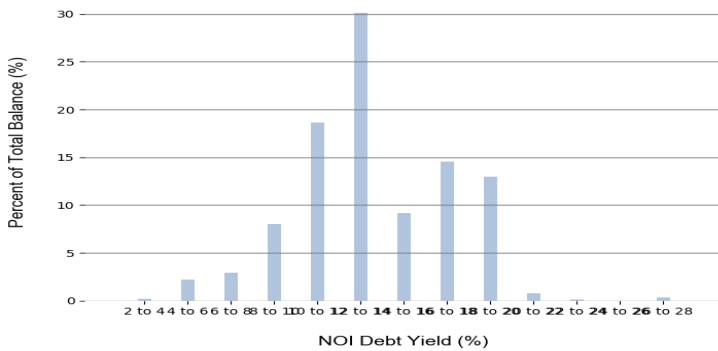

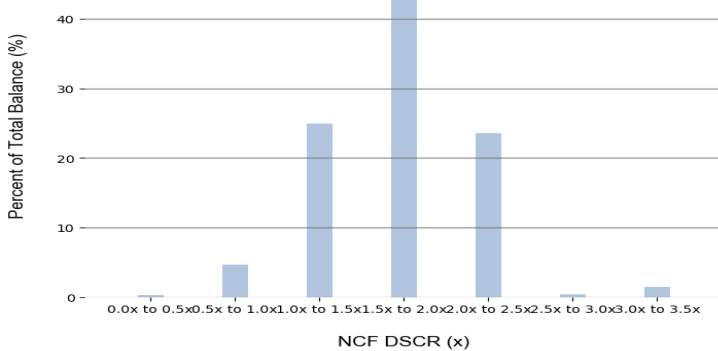
NOI Debt Yield (%)

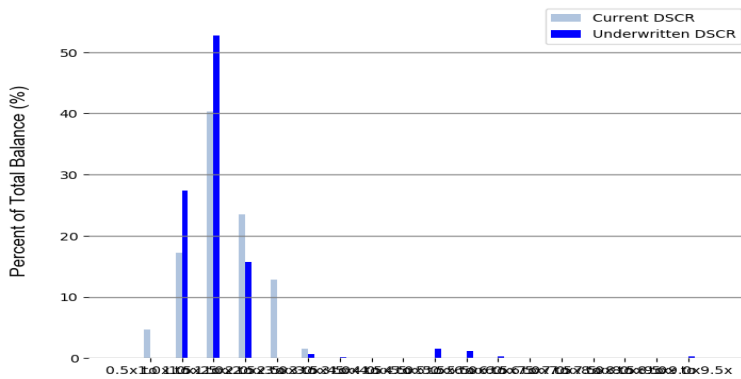

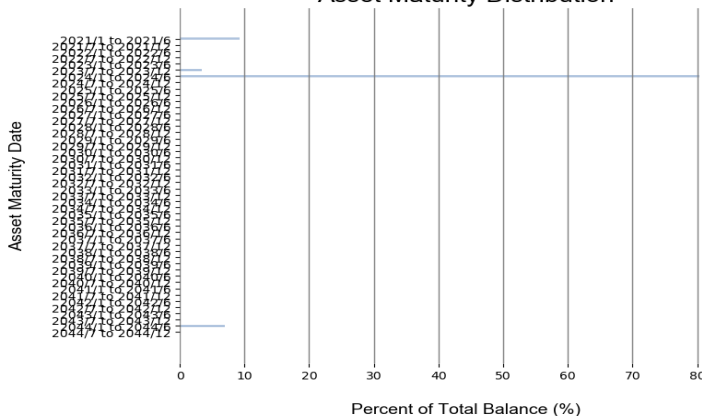
DSCR Distribution (x)



DSCRs ranged from 0.5x to 3.5x. There are 6 assets (4.6% of total balance) with DSCR between 0.5x and 1.0x, 19 assets (17.2% of total balance) with DSCR between 1.0x and 1.5x, 30 assets (40.3% of total balance) with DSCR between 1.5x and 2.0x, 24 assets (23.5% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (12.8% of total balance) with DSCR between 2.5x and 3.0x and 4 assets (1.6% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 1.9x.

There are 1 assets (9.3% of total balance) that have maturity dates between 2021/1 and 2021/6, 3 assets (3.4% of total balance) that have maturity dates between 2023/7 and 2023/12, 83 assets (80.3% of total balance) that have maturity dates between 2024/1 and 2024/6 and 2 assets (7.0% of total balance) that have maturity dates between 2044/1 and 2044/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
