## **Transaction Summary**

The transaction closed on Mar 28 2014 and matures in Mar 2044. The pool's current aggregate principal balance is \$865.1 million compared to \$1001.4 million at close.

The largest loan of the pool (9.2%) is secured by Renaissance Chicago Downtown located in metropolitan area. Occupancy at the subject was 51%. The second largest loan of the pool (6.6%) is secured by Life Time Fitness Portfolio located in Washington-Arlington-Alexandria, DC-VA-MD-WV-20.07% metropolitan area. Occupancy at the subject was 100%. The largest tenant was LTF Club Operations Company Inc. (100.00%). The third largest loan of the pool (6.0%) is secured by Nordic Cold Storage Portfolio located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Nordic Cold Storage LLC (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.99% and 97 months as of 03/15/2022, respectively. There are a total of 87 loans and 108 properties in the portfolio. The appraisal LTV was approximately 61.9% compared to the Original loan to value (LTV), which was approximately 63.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.33x. As of 03/15/2022, 9.25% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





## Occupancy Distribution (%)






#### Local Distribution







# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

- 2) The credit rating was based solely upon the merits of the obligor, security, or money market instrument being rated, and
- 3) The credit rating was an independent evaluation of the credit risk of the obligor, security, or money market instrument.
