Transaction Summary

The transaction closed on Aug 12 2014 and matures in Aug 2024. The pool's current aggregate principal balance is \$1167.6 million compared to \$1267.6 million at close.

The largest loan of the pool (7.7%) is secured by Fairview Park Drive located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 41%. The major tenants included BAE Systems Inc. (47.03%) and Deloitte & Touche (9.98%). The second largest loan of the pool (7.5%) is secured by Queens Atrium located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included City Of New York (25.08%) and City of New York (22.45%). The third largest loan of the pool (5.2%) is secured by Highland Portfolio located in Warren-Troy-Farmington Hills, MI-100.00% metropolitan area. Occupancy at the subject was 89%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.64% and 77 months as of 12/15/2020, respectively. There are a total of 109 loans and 133 properties in the portfolio. The appraisal LTV was approximately 69.7% compared to the Original loan to value (LTV), which was approximately 63.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.68x. As of 12/15/2020, 1.82% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.





Occupancy Distribution (%)




Local Distribution





There are 1 assets (0.5% of total balance) with DSCR between -0.5x and 0.0x, 2 assets (2.6% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (2.1% of total balance) with DSCR between 0.5x and 1.0x, 22 assets (21.1% of total balance) with DSCR between 1.0x and 1.5x, 37 assets (32.2% of total balance) with DSCR between 1.5x and 2.0x, 23 assets (32.2% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (4.4% of total balance) with DSCR between 2.5x and 3.0x, 6 assets (3.3% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.2% of total balance) with DSCR between 3.5x and 4.0x, 2 assets (1.0% of total balance) with DSCR between 4.0x and 4.5x, 1 assets (0.3% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (0.2% of total balance) with DSCR between 9.0x and 9.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
