Transaction Summary

The transaction closed on Sep 30 2014 and matures in Sep 2025. The pool's current aggregate principal balance is \$778.4 million compared to \$851.2 million at close.

The largest loan of the pool (15.0%) is secured by Bank of America Plaza located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 84%. The major tenants included The Capital Group Companies (24.45%) and Bank Of America (14.62%). The second largest loan of the pool (8.9%) is secured by Crossing at Corona located in metropolitan area. Occupancy at the subject was 75%. The major tenants included Kohl's Department Store (10.44%) and Regal Cinemas (9.65%). The third largest loan of the pool (9.1%) is secured by Columbus Square Portfolio located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 94%. The major tenants included Whole Foods Market (24.27%) and Quick Park Garage LLC (21.94%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.37% and 91 months as of 04/15/2022, respectively. There are a total of 73 loans and 92 properties in the portfolio. The appraisal LTV was approximately 64.9% compared to the Original loan to value (LTV), which was approximately 66.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.45x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.





Occupancy Distribution (%)




Local Distribution









DSCRs ranged from 0.0x to 7.0x. There are 4 assets (5.6% of total balance) with DSCR between 0.0x and 0.5x, 6 assets (6.0% of total balance) with DSCR between 0.5x and 1.0x, 16 assets (38.6% of total balance) with DSCR between 1.0x and 1.5x, 21 assets (21.7% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (20.3% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (4.0% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (1.8% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (1.4% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.2% of total balance) with DSCR between 4.0x and 4.5x, 1 assets (0.3% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (0.2% of total balance) with DSCR between 6.5x and 7.0x. There are 9 assets (48.8% of total balance) that have maturity dates between 2024/1 and 2024/6, 63 assets (703.9% of total balance) that have maturity dates between 2024/7 and 2024/12 and 1 assets (25.7% of total balance) that have maturity dates between 2025/7 and 2025/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
