## **Transaction Summary**

The transaction closed on Nov 18 2014 and matures in Nov 2044. The pool's current aggregate principal balance is \$1093.3 million compared to \$1138.0 million at close.

The largest loan of the pool (9.5%) is secured by St. Johns Town Center - Pooled located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Nordstrom (12.54%) and Dick's Clothing and Sporting Goods (7.64%). The second largest loan of the pool (13.4%) is secured by St. Johns Town Center - NonPooled located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Nordstrom (12.54%) and Dick's Clothing and Sporting Goods (7.64%). The second largest loan of the pool (13.4%) is secured by St. Johns Town Center - NonPooled located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Nordstrom (12.54%) and Dick's Clothing and Sporting Goods (7.64%). The third largest loan of the pool (8.0%) is secured by Two Westlake Park located in metropolitan area. The weighted average coupon (WAC) and the weighted average age (WALA) were 4.32% and 74 months as of 12/15/2020, respectively. There are a total of 74 loans and 97 properties in the portfolio. The appraisal LTV was approximately 82.5% compared to the Original loan to value (LTV), which was approximately 59.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.01x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.



Type Concentration







Among assets in the portfolio, there are 21 properties (33% of total balance) located in Florida, 19 properties (19% of total balance) in California, 13 properties (14% of total balance) in Texas, 2 properties (7% of total balance) in New York, 2 properties (3% of total balance) in North Carolina, 4 properties (3% of total balance) in Georgia, 2 properties (3% of total balance) in Pennsylvania, 1 property (2% of total balance) in Oregon and 4 properties (2% of total balance) in Illinois. Other properties are located in the state of Illinois, Ohio, New Jersey, Michigan, Louisiana, Utah, Kansas, Indiana, Tennessee, Hawaii, Arizona, Colorado, Montana, Washington, Maryland, South Carolina, Minnesota and New Mexico.







## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
