Transaction Summary

The transaction closed on Nov 18 2014 and matures in Nov 2044. The pool's current aggregate principal balance is \$986.8 million compared to \$1042.0 million at close.

The largest loan of the pool (10.5%) is secured by St. Johns Town Center - Pooled located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Nordstrom (12.54%) and Dick's Clothing and Sporting Goods (7.64%). The second largest loan of the pool (14.8%) is secured by St. Johns Town Center - NonPooled located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Nordstrom (12.54%) and Dick's Clothing and Sporting Goods (7.64%). The third largest loan of the pool (7.6%) is secured by Gateway Center Phase II located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included JC Penney (20.34%) and Big V Shoprite Supermarket (14.91%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.33% and 90 months as of 04/15/2022, respectively. There are a total of 72 loans and 95 properties in the portfolio. The appraisal LTV was approximately 58.1% compared to the Original loan to value (LTV), which was approximately 57.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.05x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.





Occupancy Distribution (%)















There are 2 assets (2.2% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (5.5% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (16.7% of total balance) with DSCR between 1.0x and 1.5x, 19 assets (22.2% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (8.8% of total balance) with DSCR between 2.0x and 2.5x, 14 assets (33.3% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (4.9% of total balance) with DSCR between 3.0x and 3.5x, 5 assets (5.6% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.2% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.6% of total balance) with DSCR between 5.5x and 6.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
