# **Transaction Summary**

The transaction closed on Dec 12 2014 and matures in Dec 2044. The pool's current aggregate principal balance is \$787.4 million compared to \$831.6 million at close.

The largest loan of the pool (12.7%) is secured by St. Johns Town Center - Trust located in metropolitan area. Occupancy at the subject was 95%. The major tenants included Nordstrom (12.54%) and Dick's Clothing and Sporting Goods (7.64%). The second largest loan of the pool (12.0%) is secured by Colorado Mills located in metropolitan area. Occupancy at the subject was 81%. The major tenants included United Artists (8.98%) and Burlington Coat Factory (6.88%). The third largest loan of the pool (8.6%) is secured by Plaza Vista located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Polsinelli Shatton Flanigan Suelthaus PC (92.57%) and Jax Fish House KC LLC (2.05%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 73 months as of 12/15/2020, respectively. There are a total of 55 loans and 66 properties in the portfolio. The appraisal LTV was approximately 58.6% compared to the Original loan to value (LTV), which was approximately 59.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.38x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.





### Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 4% to 33% with a weighted average NOI debt yield of 13.6%. NOI debt yield ranged from 4% to 33%. 



DSCRs ranged from 0.5x to 5.0x. There are 1 assets (3.9% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (3.2% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (29.6% of total balance) with DSCR between 1.5x and 2.0x, 21 assets (30.1% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (11.5% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (2.7% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (5.8% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (12.7% of total balance) with DSCR between 4.5x and 5.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
