Transaction Summary

The transaction closed on Jul 26 2017 and matures in Jul 2022. The pool's current aggregate principal balance is \$148.7 million compared to \$150.0 million at close.

The single asset of the pool is secured by West Town Mall - Pooled located in Knoxville, TN. Occupancy at the subject was 91%. The major tenants included Belk Women's Store (21.04%) and Belk Men Home & Kids (18.55%).



The weighted average coupon (WAC) and the weighted average age (WALA) were 4.37% and 39 months as of 10/05/2020, respectively. There are a total of 1 loans and 1 properties in the portfolio. The appraisal LTV was approximately 55.3% compared to the Original loan to value (LTV), which was approximately 56.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.18x. As of 10/05/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.






Occupancy Distribution (%)



Among all the assets in the portfolio, 100% of total balance had LTVs between 50% and 60%.









EJR's Key Rating Features & Differences Compared With Other NRSROs

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
