Federal Agricultural Mortgage Corporation Class C (AGM) is in the govt support firms sector and its operating income was \$91.5M for the quarter ending June 2021 vs. \$45.1M for the prior year. Net income for the June 2021 quarter was \$31.3M vs. the prior year's \$35.6M income.

Federal Agricultural Mortgage Corp. is a stockholder-owned, federally chartered corporation, which engages in the provision of a secondary market for agricultural real estate and rural housing mortgage loans, rural utility loans, and loans guaranteed by the United States Department of Agriculture. The company was founded in 1987 and is headquartered in Washington, DC. On August 18, 2021, AGM announced it is enhancing its operations by expanding its internal loan servicing function. Farmer Mac purchased all of Conterra's servicing rights to loans owned by Farmer Mac, covering a sizeable portion of Farmer Mac's total Farm & Ranch and USDA Guaranteed loan portfolios. Net income dropped by 13.9% due to the \$3.1M losses on financial derivatives. For FQE Jun '21, interest income and interest expense both decreased by 12.3% and 26.8%, resp, which resulted in a 13.9% growth in net interest income to \$41M. Commissions & fees earned remained flat at \$3M, while other operating income rose by 7.1% to \$15M. Funds from operations of \$91.5M resulted in funds from operations interest coverage of 1.8x. Regarding leverage, total debt rose from \$21.4B to \$21.7B as total shareholder's equity grew from \$0.8B to \$1.2B, which led to a leverage ratio of 94.8%. Net debt was \$20.9B and the resulting net leverage ratio was 94.6%. Market capitalization of \$1.0B as of August 30, 2021 and net debt of \$20.9B generated a ratio of 0.1:1. The share price of \$99.11 as of August 27, 2021 was higher by 32.6% compared to \$74.76 on January 4 (the beginning of the year and the lowest point year-to-date). A dividend of \$0.88 per share of common stock is payable on September 30, 2021. Affirming.



The Company's interest income rose at an average rate of 7.10% over the last five years while Operating Margin rose to 2.84% for the fiscal year ending December 2020, above the 1.07% average over the prior four years. Return on Assets fell to 0.44%, below the 0.50% average for the prior years.

VALUATION DRIVER: Interest Income Growth

Federal Agricultural Mortgage Corporation Class C (AGM) has seen a decline in interest income at 17.9% per annum in the last fiscal year. We expect the Company's revenues will decline approximately 8.6% per annum over the next couple of years and 0.5% per annum for the next couple of years thereafter.

VALUATION DRIVER: Net Interest Margin

The Company's net interest margin has been more than its peers and we assumed no growth in net interest margin over the next two years.



For the issue Federal Agricultural Mortgage Corporation Class C with the ticker of AGM we have assigned the senior unsecured rating of A. There are three notches in our rating categories (e.g., A- A, and A+) except for AAA and those deep into speculative grade, i.e., CC, C, and D do not have notches.

Egan-Jones is not an NRSRO (as defined by the SEC) for sovereign/municipal issuers and structured finance/ABS issuers.
