Federal Agricultural Mortgage Corporation Class C (AGM) is in the govt support firms sector and its operating income was \$178.8M for the quarter ending September 2023 vs. \$116.5M for the prior year. Net income for the September 2023 quarter was \$58.1M vs. the prior year's \$41.4M income.

Founded in 1987 and headquartered in Washington, DC, Federal Agricultural Mortgage Corporation is a stockholder-owned, federally chartered corporation. It engages in the provision of a secondary market for agricultural real estate and rural housing mortgage loans, rural utility loans, and loans guaranteed by the United States Department of Agriculture. For the FQE Sep '23, AGM's net income soared 40.3% to \$58.1M attributable to a 29.0% advance in net interest income to \$87.6M as interest income growth more than offset the expansion in interest expense. In addition, non-interest income surged to \$9.5M (+126.7%) led by higher guarantee and commitment fee. Partially offsetting the increase in net income was a \$4.5M increase in income taxes to \$15.1M and a 23.7% expansion in operating expenses to \$24.0M primarily due to higher compensation and employee benefits and general and administrative expenses. Regarding leverage, total debt rose from \$23.5B to \$25.1B for the FQE '23 while total shareholder's equity rose from \$1.2B to \$1.4B. As a result, leverage (i.e., total debt/capital (including debt)) was 94.8%. Net Debt was \$24.3B for the most recent FQE and the resulting net leverage ratio was 94.6%. Market Cap is \$2.0B as of 01/04/2024 (a ratio of 12.5:1). Affirming.



The Company's interest income rose at an average rate of 1.71% over the last five years while Operating Margin rose to 2.93% for the fiscal year ending December 2022, above the 2.47% average over the prior four years. Return on Assets rose to 0.65%, above the 0.52% average for the prior years.

VALUATION DRIVER: Interest Income Growth

Federal Agricultural Mortgage Corporation Class C (AGM) has grown its interest income at 38.6% per annum in the last fiscal year. We expect the Company's revenues will grow approximately 1.5% per annum over the next couple of years and 1.5% per annum for the next couple of years thereafter.

VALUATION DRIVER: Net Interest Margin

The Company's net interest margin has been more than its peers and we assumed a 1.8% net interest margin over the next two years.




