RATINGS

Federal National Mortgage Association (FNMA) is in the govt support firms sector and its operating income was \$35.2B for the quarter ending March 2024 vs. \$31.6B for the prior year. Net income for the March 2024 quarter was \$4.3B vs. the prior year's \$3.8B income.

Founded in 1938 and is headquartered in Washington, DC, FNMA engages in the provision of liquidity for purchases of homes and financing of multifamily rental housing and refinancing existing mortgages. On Apr 09, 2024, VRMTG ACQ, LLC completed its acquisition of Non-Performing Loans from the Company (FNMA). For the quarter ended Mar'24, the Company's net income increased by 14.53% YoY primarily attributable to higher revenues. The Company's revenues rose by 6.8% YoY (-2.9% seq.) for FQE Mar'24 mainly due to a (+9.6%) increase in interest income and is partially offset by higher interest expense (+11.2%). Operating income increased from \$31.6B last year to \$35.2B this year (+11.5%) as a result of the \$3.2B (+9.6%) rise in interest income and the \$0.1B (-100.0%) decline in provisions for loan losses. Funds from operations for the FQE Mar'24 were \$35.2B resulting in a funds from operations interest coverage of 1.2x. Regarding leverage, total debt was almost flat at \$4.2T for the FQE '24 while total shareholder's equity rose from \$64.0B to \$82.0B. As a result, leverage was 98.1%. Net debt was \$4.2T for the most recent FQE and the resulting net leverage ratio was 98.1%. Market Cap is \$1.78B (as of 06/04/2024). Affirming. Other raters might take positive actions.



VALUATION DRIVER: Interest Income Growth

Federal National Mortgage Association (FNMA) has grown its interest income at 16.1% per annum in the last fiscal year. We expect the Company's revenues will grow approximately 3.1% per annum over the next couple of years and 3.1% per annum for the next couple of years thereafter.

VALUATION DRIVER: Net Interest Margin

The Company's net interest margin has been less than its peers and we assumed a 0.3% net interest margin over the next two years.





For the issue Federal National Mortgage Association with the ticker of FNMA we have assigned the senior unsecured rating of A. There are three notches in our rating categories (e.g., A- A, and A+) except for AAA and those deep into speculative grade, i.e., CC, C, and D do not have notches.
